As per the retirement notifications issued vide G.O.Os 1st to 3rd cited, certain Engineers mentioned in the Annexure have retired from service on attaining the age of superannuation of 58 years on the dates mentioned against each.

2. In the G.O.O. 4th read with G.O.O. 5th cited, it has been ordered that the age of retirement on superannuation of an employee of the Board (APGENCO) is the date on which he attains the age of 60 years. These orders shall come into force with retrospective effect from 02.06.2014. Further in the memo 6th cited, instructions have been issued to effect re-induction of retired employees consequent to issuance of the aforesaid G.O.Os 4th & 5th.

3. In pursuance of the orders issued in the G.O.O. 4th read with G.O.O. 5th cited they are eligible for re-induction into service as they have not attained the age of superannuation of 60 years, provided that they remit back the pensionary benefits (viz.(a)Commuted value of Pension, (b)Retirement Gratuity (c) Encashment of Earned Leave), along with interest thereon in terms of orders issued vide memo 6th cited.

4. Therefore, they are requested to remit the said amounts (inclusive of interest up to 31.08.2017) on or before **30.09.2017** by way of DD/Cheque/On line transfer to SBI Specialized Mid Corporate Branch, Vijayawada, Account No:52077965022, so as to enable this office for issue of re-induction orders. Further, interest per day shall be levied towards the said pensionary benefits, till date of remittance. The DD should be drawn in favour of Pay Officer/APGENCO.

5. Re-induction orders will be issued after 30.09.2017 only. However, the period from the date of remittance to the date of issue of re-induction orders will be treated as compulsory wait.

6. No further correspondence is entertained in this regard.
