1. Name of the Public Sector Utility: APGENCO
2. Company profile : APGENCO was incorporated under the Indian Companies Act 1956 as wholly owned State Government Company. It is one of the pivotal Organization of Andhra Pradesh, engaged in the business of Power Generation. Apart from operation & Maintenance of the power plants, it has undertaken the execution of the ongoing & new power projects scheduled under capacity addition programme and is taking up renovation and modernization works of the old power stations.

The existing installed capacity of APGENCO is 5612 MW comprising 3410 MW Thermal, 1797 MW Hydro, 405 MW Solar power stations
3. Name of the post : Director (Coal & Logistics)
4. Age of Applicant : The applicant shall not be above 62 years of age as on the date of notification.
5. Qualification : The applicant shall have minimum Bachelor degree i.e., B.E/B.Tech (Mining) from a College/University recognized by AICTE (or) M.Sc(Geology) from recognized university approved by State GOVT/UGC.
6. Eligibility Criteria :

a) The applicant shall have at least 20 years of professional experience in coal sector with State/Central Government and Government undertakings.

b) The applicant shall have 5 years of service experience in the individual/combined cadres of General Manager (Marketing & Sales)/Executive Director/ Director (Operations and Technical) or equivalent rank in the State/ Central Government and Government undertakings of Coal Sector.
7. Additional Qualifications :

a) The applicant shall have good knowledge in Mining sector, logistics in Rail, Sea & Road modes and also have carried out the liaising with Coal companies such as Coal India Ltd, Mahanadi Coalfields Ltd, and Singareni Collieries Company Ltd etc., and Railways for materialization of Coal linkage.

b) First Class Mining Manager Certificate from DGMS (Directorate General of Mines Safety).

8. Tenure of appointee : Directors shall be selected initially for a term of two (2) years. The tenure of the appointee may be extended for a period of one(1) year at a time up to a maximum of two (2) extensions. All decisions related to extension of tenure shall be made after the approval of the competent authority with the recommendation of the selection committee based on the yearly assessment report of the Director. Candidates with outstanding assessment only shall be considered for re-appointment.
9. Emoluments : a) Lumpsum amount of Rs.90,000/- per month
Allowances: Security Guard Allowance- Rs.10,796/- & Telephone Operator Allowance- Rs.10,796/- shall be paid.
b) Professional Development allowance – Rs.20,000/-
c) Special Allowance - Rs.25,000/-
d) Camp Office allowance -Rs.30,000/-
e) 10% on the lumpsum amount shall be enhanced every year.
10. Job Description and Responsibilities : As decided and entrusted by the Board/Managing Director/APGENCO.
11. Submission of applications : i) In the prescribed format along with enclosures (As annexed) well in advance not later than 31.10.2019, 5.00 P.M duly super scribing the post for which applied and addressed to Managing Director, 3rd floor, APGENCO, Vidyut Soudha, Vijayawada.
ii) APGENCO under any circumstances will not entertain the information if any furnished by the candidate subsequently. Applicants should be careful in filling up the application form at the time of submission. If any lapse is detected during the scrutiny the candidature will be rejected even though he/she comes through the final stage of recruitment process or even at later stage. The candidate should not furnish any false /tempered/ fabricated information or suppress any material information while filling of the application form.
