- (iv) Therefore, it is warned not to repeat the same in future.
- (v) On assumption of charge as CE/O&M/Dr.NTTPS, she is directed to obtain prior approval from the Managing Director while issuing transfer and postings to the personnel and engaging, replacement of Contract Labour or outsourced employment within the plant.
