May it Please Lordship

1. That I would like to draw your Lordship's kind attention to Para 27 of the Supplementary Report dated 11.3.2020 in which I have been directed to identify 584 employees (in addition to the 71 which have already been identified by this Hon'ble committee) for allocation to Telangana Power Utilities.

2. That by the accompanying letter dated 13.03.2020, I have pointed out that in the list appended to the report 221 employees, who were part of

the 502 employees retained in Telangana Power Utilities (out of the 1157 originally unilaterally relieved by Telangana Power Utilities) under the final report dated 26.12.2019, by oversight appear to have been shown in the annexed list of report dated 11.03.2020 to be with the Andhra Pradesh Power Utilities. I have requested that since the error appears to be due to some oversight, it needs to be rectified.

3. That out of the remaining employees, actually working with the Andhra Pradesh Power Utilities on "Order to serve Basis", I have in compliance of the directions contained in Para 27 of the Report dated 11.03.2020 identified 584 employees who need to be allocated to Telangana Power Utilities in the final list to be endorsed by this Hon'ble Committee. A List of the said 584 employees identified under the directions contained in Para 27 of This Hon'ble Committee Supplementary report dated 11.3.2020 is annexed herewith and marked as **Annexure R-2**.

4. That the aforesaid 584 employees have been identified by the undersigned by the following principle adumbrated in the working modalities approved by your lordships for the subcommittee members on 17-04-2019.

- (a) The list of incoming 655 employees allocated to the Andhra Pradesh Power Utilities:
 - (i) The incoming employees were segregated cadre-wise and rank wise
 - (ii) Within each rank, the incoming employees were arranged in the order of seniority.
- (b) For identification of the outgoing 584 employees Company wise and rank wise (in addition to the 71 already identified by the committee):

- (i) The 71 employees identified by the committee have been segregated rank-wise and cadre wise and matched with the incoming list.
- (ii) The remaining employees working on "order to serve basis" in Andhra Pradesh Power Utilities have been enumerated Cadre-wise and Rank-wise in order of seniority.
- (iii) The employee who has opted for Telangana Power Utilities have been allotted to the Telangana Utilities rank-wise and cadre wise and matched with the incoming list.
- (iv) The aforesaid identification was continued, in order of seniority, till those who opted for TS are exhausted.
- (v) Once the list of those who opted for Telangana Utilities was exhausted, the Junior most employee was allotted on "order to serve basis" in that cadre/rank.

5. The aforesaid exercise has been carried out such that:-

- a) The process of allocation remains "financially neutral", so that cadre-wise/rank-wise matching has been done for every rank and allotment of the 655 employees from Telangana Utilities to Andhra Pradesh Power Utilities, a similar rank wise balancing reverse allocation has been done, thus the 655 allotted from Telangana Utilities to Andhra Pradesh Utilities has been balanced with a reciprocal allotment of 655 employees from Andhra Pradesh Utilities to Telangana Utilities.
- b) In identification of the 584 to be allotted to Telangana Utilities has been done only from the employees actually working on "order to serve basis" in Andhra Pradesh Power Utilities so that the said identification does not disturb the 655 employees identified and allotted by the committee from Telangana Utilities to Andhra

Pradesh Utilities as directed in the Supplementary Report dated 11.03.2020.

- c) The 584 employees identified are in addition to the 71 special cases already identified and approved by this Hon'ble Committee to bring the total matching allocation from Andhra Pradesh Utilities to Telangana Utilities at 655.

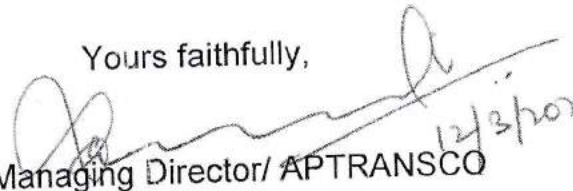

It is submitted that with the completion of the aforesaid identification of 584 employees and the rectification as submitted in my accompanying letter dated 12.03.2020 for re-designation of the 221 employees, the process of allocation by this Hon'ble committee stands finally completed.
