The Letter will be addressed to TSGENCO for obtain consent for repatriation. After receipt of consent from TSGENCO the relieving request will be considered. She has promoted as JAO at SE/E&M/PJHES dt.31.08.2010 i.e. before bifurcation of the state. As the Jurala station comes under Zone-6 which is covered under Telangana State. But Smt B.A.Mangatayaru who is working at Headquarters from PJHES w.e.f 01.12.2010 FN to till date on deputation only. Even on temporary allocation of the Employees in

			between TS and AP also she was not repatriated to parent unit and temporarily allotted to A.P and working at VS on Deputation basis from Jurala (Teleangana Zone).Hence her name is not included in the seniority list of JAO's of APGENCO as her lien and seniority is being maintained by Jurala unit i.e., PJHES (TSGENCO)
3	V.Ravi Kumar (1018166)	Requested to include previous JAO service of 16 months i.e from 02.01.2017 to 09.04.2018. Reverted as UDC and worked from-10.04.2018 To 31.12.2018 and from 01.01.2019 again he has been promoted as JAO and working till date.	As the service rendered in the cadre of JAO from 02.01.2017 to 09.04.2018 shall not be entertained in any manner as he was reverted and again worked as UDC from 10.04.2018 to 31.12.2018. Hence the latest date of joining i.e 01.01.2019 in JAO cadre considered for seniority.
4	V.Mallika(1073577)	Requested to include in the seniority list	She has appointed as a JAO(DR)at KTPP/Bhupalapally and joined on 12.10.2010 F.N before bifurcation of the state. As the KTPP station comes under Zone-5 which is covered under Telangana State. But Smt V.Mallika who is working at RTPP from KTPP w.e.f 03.12.2010 FN has not repatriated to parent unit and temporarily working on deputation basis at CE/O&M/RTPP. Hence her name is not included in the seniority list of JAO's as she is covered in Zone-5 which is comes under Telangana-Zone and her lien and seniority is being maintained by KTPP (TSGENCO)
5	A.Ramakrushna (1062138)	Requested to relieve him from APGENCO to his parent unit i.e SLBHES (TSGENCO)	The Letter will be addressed to TSGENCO for obtain consent for repatriation. After receipt of consent from TSGENCO the relieving request will be considered. He has deputed to APPDCL from SLBHES before bifurcation of state and relieved on 25.11.2013 and reported for duty as JAO at SDSTPS and working as JAO till date. As the SLBHES station comes under Zone-5.which is covered under Telangana State. But Sri A.Rama Krishna is working on deputation at SDSTPS from SLBHES w.e.f 26.11.2013 FN. He has not repatriated to parent unit and temporarily working on deputation at SDSTPS. Hence his name is

			not included in the seniority list of JAO's as he is covered in Zone-5, which is comes under Telangana-Zone. and his lien and seniority is being maintained by SLBHES (TSGENCO)
6	M.S.Vasanth Kumar(1062185)	Requested to correct his caste as BC-C as per caste the Certificate. And also requested to add his name in PH quota.	Verified with S.R and caste certificate corrected caste as BC-C. The Point raised by the party to cover under PH quota does not arise as he has promoted as JAO as per the seniority. The common seniority of JAO's will be fixed based on their Date of Joining as JAO in the station.
