The question of regularization of services in the category of JAO have been examined and accordingly, the following orders are issued.

2) After careful consideration, under Regulation 23 (a) of APSEB Service Regulations Part-II read with Regulation 16 (a) (i) of APSEB Service Regulations Part-III as adopted by APGENCO the services of 20 No. of Junior Accounts Officers indicated in the annexure appended to these orders are hereby regularized in the category of Junior Accounts Officer and they are placed on probation for a total period of two years on duty within a continuous period of 3 years with effect from the dates noted against their names in the Column No.5 of the annexure duly arrived commencement dates as per merit orders cum Roster.

3) The seniority of Junior Accounts Officer appended to the order will be fixed later.

4) The Junior Accounts Officers are informed that they should pass the following tests at prescribed in the regulation during their probation period.

- i) Accounts test for Subordinate Officers Part-I of APPSC.
- ii) Department test of Accounts in Electricity Board.
- iii) Govt. Technical Examination in Accountancy by Higher Grade.

Members who possess B.Com degree of a university (with accountancy as compulsory subject) need not pass the Govt. Technical Examination in Accountancy by Higher Grade referred item(iii)above.

5) These orders are issued subject to the condition that they services are liable to be terminated at any time before declaration of completion of probation with one months notice or with one month pay in lieu thereof.
