In the reference 2nd cited, the Chief Engineer/O&M/RTPP has informed that, Sri R.Mani Prasad Reddy, Dy.Executive Engineer /Elecl was absent to duty with effect from 23.11.2019 onwards without prior sanction/permission from the competent authorities and hence surrendered the said Dy.EE to Head Quarters for taking necessary action. In the reference 1st cited, explanation of Sri R.Mani Prasad Reddy, Dy.Executive Engineer /Elecl was called for his unauthorized absence to duty from 23.11.2019 F.N. onwards. He has not submitted any explanation to the said memo. It was also informed therein if no explanation is received within the stipulated period, further action will be taken, deemed fit, based on the material evidences on record.

2) In terms of Regulation 28 (3) (a) of APSEB Service Regulations Part-I amended vide G.O.O.No.25/JS(Per)/2008, Dated: 23.04.2008, an employee of APGENCO shall be deemed to have resigned from service if he is absent without authorization for a period exceeding 'one year'. As per the records made available, Sri R.Mani Prasad Reddy, Dy.Executive Engineer /Elecl /RTPP (Surrendered to HQs) is unauthorizedly absence to duty for a period exceeding more than a year.

3) Therefore the Managing Director/APGENCO being the disciplinary authority, after careful examination of the case in its entirety, has come to the provisional conclusion to impose the penalty of **"Deemed to have resigned from service"** against Sri R.Mani Prasad Reddy, Dy.Executive Engineer /Elecl /RTPP (Surrendered to HQs) in terms of G.O.O.No.25/JS(Per)/2008, Dated:23.04.2008.

4) Sri R.Mani Prasad Reddy, Dy.Executive Engineer /Elecl /RTPP (Surrendered to HQs) is therefore, directed to Show cause within 15 days from the date of receipt of this memo, as to why the penalty proposed above should not be imposed against him.

5) He is further informed that if his explanation is not received within the stipulated time, it would be construed that he has no explanation to offer and further action would be taken against him based on the material available on records.
