Under Regulation - 14 (a) (1) of A.P.S.E.B. SRs Part -II, as adopted, Smt S. Soujanya, Assistant is promoted to act temporarily as Junior Personnel Officer with effect from the date of assumption of charge.

2. The promotion ordered in para -1 above is purely temporary and liable to be terminated at any time without notice and without assigning any reasons thereto.

3. The promotion ordered above is subject to the result/review of final allocation of State cadre employees between APGENCO & TSGENCO, that may occur as per the AP Re-Organization Act, 2014, besides subject to the outcome of Batch of MA No.1286/2020& Batch CA No.11435/2018, pending before the Supreme Court of Judicature.

4. Smt S. Soujanya, Assistant on promotion as Junior Personnel Officer is transferred and posted as JPO/Medical (I section) to the control of Asst.Secretary(Medical) O/o CGM(Adm,IS&ERP)/VS/VJA in one of the existing vacancies.

5. The concerned controlling officer is requested to relieve the above Assistant by making local arrangements within 15 days from the date of issue of this order, otherwise the promotee shall be treated as deemed to have been relieved of his/her duties after expiry of the stipulated period.

6. She is requested to assume charge on promotion as Junior Personnel Officer at the place of posting ordered. If she fail to join or evade joining within the stipulated period or proceeded on leave from the date of receipt of this order, her promotion right shall be forfeited for the current panel and the name of the candidate shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancies, in terms of orders issued vide reference 1st cited. Necessary departmental disciplinary action as deemed fit shall also be initiated against her for non-compliance of the orders issued above. No request for change of posting or sanction of leave will be entertained.
