In the references cited, promotions have been issued to employees of engineering services, with a direction to the Controlling Officers to relieve the promotees by making local arrangements, so as to enable them to join at the place of posting.

2. Further the promotees are requested to assume charge at the place of posting on promotion. If the promotees fail to join or evade joining within the stipulated period or proceed on leave, their promotion shall be forfeited for the current panel year and the name of such candidate will be placed before the next DPC for consideration, subject to availability of vacancy. It is also informed that necessary departmental disciplinary action deemed fit will be initiated against the employees for non-compliance of the orders.

3. It is noted by the management with much displeasure that in spite of the above instructions, some of the promotees did not get relieved at the present place of working and report at the place of posting. Non compliance of these instructions would refrain the promotees of their right of promotion. Hence the concerned Chief Engineers are directed to relieve the promotees immediately by making local arrangements and if anyone not relieved, they are deemed to have been relieved by 20/5/2021AN. It is requested to arrange to intimate the status of relief of the promotees to this office by mail by 21/5/2021 positively for appraising the same to Managing Director. If the promotees do not join at the place of posting on promotion within the stipulated time, they are informed that their promotion stands cancelled as mentioned in their respective promotion orders.
