Sub:- APGENCO – Regulations – Relief/Payment of funeral charges in case of Death of Pensioners in receipt of Service Pension and extend the similar relief to the Spouse of the Pensioner pre-deceases, the Pensioner - Clarification – Orders – Issued .

In the reference 1st cited, orders were issued to effect the relief in the event of death of a retired government employee who is in receipt of service pensioner, a lumpsum amount equal to one month's pension subject to a minimum of Rs. 150/- shall be payable to the nominee nominated by the pensioner. Subsequently, while enhancing the minimum relief to Rs. 10,000/- also extended the similar relief in cases where the spouse of the pensioner predeceases the pensioner vide G.O.Ms.No.102 Finance (Pen.I) Department, dt. 06.04.2010 (referred under ref 2nd cited). The same was adopted by APGENCO vide G.O.O.No.40/JS(Per)/2010, Dt.20.4.2010 (referred under ref 3rd cited). In the reference 5th cited, the existing minimum amount of death relief of Rs. 10,000/- was finally raised to Rs. 15,000/- and the same G.O. Ms.No.39, dtd.08.03.2016 was adopted in APGENCO vide G.O.O. 46/JS(Per)/ 2016, dt. 10.05.2016.

2. In Memo. dt. 29.03.2016 (referred under ref., 4th cited) clarification orders were issued in reply to the request made by certain unions duly instructing all the Functional Heads of APGENCO to implement the orders issued vide G.O.Ms.No.102 Finance (Pen.I) Department, dt. 06.04.2010 as adopted by APGENCO vide G.O.O.No.40/JS(Per)/2010, Dt.20.4.2010.

3. After careful consideration, all the Functional Heads at Corporate Office and Station Heads of APGENCO are hereby instructed to follow the orders issued by GoAP vide G.O.Ms.No.102, dt. 06.04.2010, G.O.Ms.No. 39, dtd. 08.03.2016 as adopted by APGENCO vide G.O.O.No.40/JS(Per)/ 2010, Dt.20.4.2010 and G.O.O.No.46, dt. Dt. 10.05.2016 respectively, for payment of funeral charges to the death of service pensioner/spouse of the pensioner pre-deceases the pensioner, "shall be a lumpsum amount equal to one month's pension subject to a minimum of Rs.15,000/-."
