Smt. Dhulipalla Rajeswari, (Emp.I.D.No.1077712), was appointed as Trainee Jr. Plant Attendant under direct recruitment and posted to the control of SE/Civil Circle/NSTPD/Satrasala, and joined duty on 09.10.2013 FN vide reference (2) cited. Later she was deputed to the control of CEE/O&M/Dr.NTPS from NSTPD/Satrasala.

2. The SE/Civil/NSTPD/Satrasala has sent the antecedent reports to the Superintendent of Police of Guntur, Krishna District, Khammam, and East Godavari District vide reference (3) cited, for verification. In the reference (4) cited, the Additional General of Police Intelligence, A.P., Hyderabad, has sent the verification reports to the SE/Civil/NSTPD, and the same was sent to this office vide reference (5) cited. In the antecedent reports it was noticed that, **"The ITI Certificate Sl.No.30208501 of Smt. D. Rajesswri, JPA, was found to be Fake"**. The same was intimated to the Joint Secretary (Personnel), APGENCO., Vidyut Soudha, Hyderabad for further action on the above matter vide reference (6) cited.

3. In the reference (7) cited, JS (Personnel), has issued instructions for dismissal of the incumbent from service duly following the procedure. Accordingly, Enquiry Officer was appointed to enquire the above case vide reference (8) cited. The Enquiry Officer submitted the enquiry report vide reference (9) cited, and stated that Smt. Dhullipalla Rajeswari, JPA has not having sufficient proofs supporting her qualification, and she has not attended the enquiries scheduled on 04.11.2016, 16.11.2016, 08.12.2016, 10.01.2017 and 10.03.2017. The enquiry got delayed due to non co-operation of Smt. D. Rajeswari, JPA, and not informed any reason in time for not attending the enquiries schedules. The Enquiry Officer has recommended to take necessary disciplinary action against Smt. D. Rajeswari, JPA for producing fake I.T.I. Certificate.

4. Further, the Joint Secretary (Personnel), APGENCO., Vidyut Soudha, Hyderabad has issued certain instruction in the reference (10) cited to re-verify the character and antecedents of Smt. D. Rajeswari, JPA, NSTPD., based on the request of the incumbent, and the same was forwarded to the SE/Civil/NSTPD for re-verification vide reference (11) cited. The SE/Civil/NSTPD has send the character and antecedents of Smt. D. Rajeswari, JPA, NSTPD., to the Additional General of Police Intelligence, A.P., Hyderabad, for re-verification vide reference (12) cited. Later the then CEE/O&M/SRB has submitted a letter to the Additional General of Police Intelligence, A.P., Hyderabad, to pursue the matter personally, and arrange the necessary verification of antecedent reports of Smt. D. Rajeswari, JPA., vide reference (13) cited.

5. The Inspector General of Police, Intelligence, Telangana State, Hyderabad send a letter to the CEE/O&M/SRB, vide reference (14) cited, stating that Smt. D. Rajeswari, D/o. Veeraiah, was appointed as JPA in NSTPD., Satrasala, Guntur Dt. A.P., and hence, the antecedent reports of said candidate may please be obtained from the Additional DGP., Intelligence Department, Vijayawada, A.P.

6. The Antecedent reports of the above individual has sent to the Additional Director General of Police, Intelligence Department, Vijayawada, A.P. vide reference (15) cited. "Finally the Antecedent reports received from the Additional Director General of Police Intelligence, A.P., Vijayawada vide reference (16) cited, informed that the re-verification of ITI Certificate (Electronic Mechanic) Sl.No.30208501 and Roll No. 22054 submitted by Dhullipalla Rajeswari, D/o. Veeralah, has been done, purportedly studied in New Tech ITC, Guntakal, Anantapuramu District during the period from 2000 to 2002 was found to be Fake and Not Genuine", and the same was transmitted to the CGM(ADM,IS&ERP), APGENCO., Vidyut Soudha, Vijayawada for taking further necessary action in the above matter vide reference (17) cited..
7. Further, based on Enquiry report submitted by DSP/Vigilance/APGENCO., that the ITI certificate submitted by the incumbent is found to be Fake and Not Genuine vide references (18) cited.
8. In the reference (19) cited, the CGM(Adm,IS&ERP)/VS/APGENCO, Vijayawada has requested to implement the orders issued in the reference 7th cited.
9. Therefore, the Chief Engineer, Elect., O&M, SRB., Srisaillam Project, being the disciplinary authority, after careful examination of the issue in its entirety, and keeping in view of all the above aspects/established facts, has come to the provisional conclusion to impose the major penalty of "Dismissal from the Service" for the misconduct of producing fake certificates and giving false information as per the Clause XXX of Regulation 6 of APSEB Discipline and Appeal Regulations adopted by APGENCO.
10. In the reference (20) cited, the concurrence committee members were appointed, and requested to submit their recommendations for taking major penalty to Smt. Dhulipalla Rajeswari, JPA, NSTPD., Satrasala (now working under the control of CEE/O&M/Dr.NTPS) of Dismissal from the Service.
11. The concurrence committee submitted their recommendations for dismissal from services of Smt. D. Rajeswari, JPA, NSTPD., as the fake ITI certificate submitted at the time of appointment as JPA., and also instructed to the SE/Civil/NSTPD to file a criminal case at NSTPD Police Station .
12. As per the recommendations of concurrence committee the show cause notice was served to the party through CEE/O&M/Dr.NTPS., who was working on deputation from NSTPD to Dr.NTPS. vide reference (21) cited, obtain the dated acknowledgement and the same transmit to this Office.

13. The Chief Engineer, Elecl., O&M, Dr.NTPS., has served the show cause notice to Smt. D. Rajeswari, JPA, by register post to the mailing address and departmental quarter. As per the information furnished by the CEE/O&MJ/Dr.NTPS., vide reference (22) cited, the post sent to her departmental quarter was returned duly mentioning that the addressee is left and the post sent to her other mailing address is delivered and the above post was taken by Sonia instead of Smt. D. Rajeswari, JPA. Also the show cause notice was sent to her departmental quarter and mailing address from this Office directly by register post and the same was returned by the postal authority.

14. Again the show cause notice was sent to Smt. D. Rajeswari, JPA to her departmental quarter and mailing address by registered post on 01-04-2021 from this office, and the same was returned.

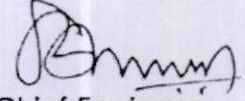
15. As per the reference (23) cited, the undersigned has furnished a letter to the CGM(ADMIS&ERP), along with paper publication notice regarding Dismissal from Service. In the reference (24) cited, the paper notification was published in **"EENADU TELUGU DAILY NEWS PAPER"** Dtd. 30-05-2021, regarding dismissal from service and informed to submit her explanation within 15 days from the date of paper publication notice Dtd. 30.05.2021 to the CE/O&M/SRB/Srisaillam Project, if her explanation is not received within the stipulated time mentioned above, it would be construed that she has no explanation to offer and action may be taken as per APGENCO Discipline and Appeal Regulations.

16. Smt. D. Rajeswari, JPA., has not submitted any explanation till to date, after completion of due date of paper publication.

17. Therefore, after careful consideration of the case in its entirety, the disciplinary authority has decided to confirm the penalty proposed in the show cause notice, i.e. dismissal from the service for the misconduct of submitting fake certificates and false information.

18. Accordingly, Smt. D. Rajeswari, JPA, Civil Circle, NSTPD., presently working under the control CEE/O&M/Dr.NTPS., on deputation, is here by awarded with the punishment of **"Dismissal from Service"**.

19. She is informed that as per Regulation 18 of APSEB Employees Discipline and Appeal Regulations, as adopted by APGENCO., only one appeal lies to the Appellate Authority/APGENCO., within three months from the date of receipt of this memo.
