Proposal has been received from the Chief Engineer/O&M/Dr.NTTPS in the reference 2nd cited for providing employment under Compassionate scheme to **Smt Pola. Sreedevi, W/o (Late) Sri Pola. Ananda Kumar, Ex- Dy.Executive Chemist/Dr.NTTPS**.

2. After careful consideration, the candidature of **Smt Pola. Sreedevi, (D.O.B. 05-06-1981), W/o (Late) Sri Pola. Ananda Kumar, Ex- Dy.Executive Chemist/Dr.NTTPS** is approved for appointment to the post of '**Junior Assistant**' under compassionate grounds and posted to the control of CE/O&M/Dr.NTTPS against the existing vacancy and deputed to the control of FA&CCA(A&T)/VS/VJA duly maintaining her lien & seniority under the control of CE/O&M/Dr.NTTPS subject to the following conditions:

- a) In the appointment orders, a clause may be incorporated that "if any information furnished by her in the proposals is found to be false, at a later date her services shall be liable for termination without any notice and without assigning any reasons thereof and further she shall be liable for punishment".
- b) In case any loans are outstanding, the same may be recovered in full, along with the interest thereon before issue of appointment orders.
- c) Necessary Affidavit with appropriate Stamp Paper attested by Notary or Oath Commissioner in the format prescribed by the Board in B.P.Ms.No.216, Dt:9.3.90 shall be obtained before issue of appointment orders. After issuing appointment orders, the contents of the affidavit shall be recorded in her Service Register.
- d) Verification of Character and Antecedents should be done.
- e) The candidate shall be governed only by provisions of EPF & MP Act 1952 and the employees PF Scheme in terms of orders issued G.O.O.No.708/ GM(Adm) /2002, dt.06.02.2003.
- f) The CE/O&M/Dr.NTTPS is requested to exercise the power of Appointment when he/she is empowered to do so;
- g) The candidate should be insisted to produce three certificates from three persons of respectable status and / or holding responsible positions verifying her conduct and character.

- h) The candidate shall be governed by the Rules and Regulations of APGENCO that are being framed from time to time.
- i) The Tripartite agreement entered into between APSEB, Govt. of AP and Employees Associations is not applicable to her and she shall at no stage be entitled to claim any right whatsoever arising out of the said Tripartite Agreement. An undertaking to this effect should be obtained from her at the time of joining duty and record the same in the Service Register.
- j) The appointment orders shall be given subject to production of physical fitness certificate issued by Medical Officer of the rank not less than that of Asst. Civil Surgeon.

3 The Chief Engineer/O&M/Dr.NTTPS is requested to follow the Rules and Regulations issued by APGENCO from time to time and appoint the incumbent positively within 10 days from the date of receipt of the order.
