In Memo.dt.30.01.2009 under ref 1st cited, certain instructions were issued to obtaining life certificate and other certificates from the Pensioners/ Family Pensioners.

2. In the reference 2nd cited, due to the present pandemic situation, the Pensioners/Family Pensioners are allowed to submit their Life Certificate in physical form up to January'2021. In memo. dt. 13.09.2021 under ref 3rd cited, for all the Drawing and Disbursing Officers of APGENCO are directed to extend assistance to the Pensioners/Family Pensioners in using the "Jeevan Pramaan" Portal for submitting annual life certificates, and also requested to all the Pensioners/ Family Pensioners to utilize the portal to submit the annual life certificates.

3. Certain Retired Employees/Associations have requested in the references 4-5th cited, to extend in submission of Life Certificates for the Pensioners / Family Pensioners of APGENCO also on a permanent basis and oblige either in physical or digital form upto 31.12.2021 as was done by APTRANSCO to their Pensioners/Family Pensioners in view of COVID-19. Futher requested to extend the facility of deputing a responsible in-Service person to the residence of the unfortunate pensioners whose mobility is restricted to allow pension based on the verification report.

4. After careful examination, it is hereby directed that all the Drawing and Disbursing Officers of APGENCO to allow all Pensioners/Family Pensioners to submit their life certificates upto 31.12.2021 either in Digital or physical form duly attested by Class-I or Class-II officer of APGENCO or any Class-I or Class-II Gazetted Officer of any Government Department in the prescribed format even if it is received through post/courier in view of the COVID-19, in addition to the orders issued vide ref 3rd cited. Further it was also directed to make a video call if necessary, to the concerned Pensioner/Family Pensioner and confirm the facts mentioned in the life certificate. In case, any Pensioner/Family Pensioner who are in immovable condition and unable to submit their life certificate, in such cases depute one officer to their place of residence for verification and allow the pension basing on the verification report. If any Pensioner/Family Pensioner prefers to submit digital life certificate, the same can be allowed.

4. These instructions shall come into force with immediate effect.
