If she fails to join or evade joining within the stipulated period or proceeded on leave from the date of receipt of this order, her promotion right shall be forfeited for the current panel year and the name of such candidate shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancies, in terms of orders issued in G.O.O. No:231/ JS(P)/08, Dated 02.08.2008. Necessary departmental disciplinary action as deemed fit shall also be initiated against her for non-compliance of the orders issued above. No request for change of posting or sanction of leave will be entertained.

7. She is directed to report for duty accordingly after obtaining proper relief from the present place of working.

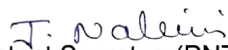
