In the references cited above, transfer/deputation orders have been issued to employees of different cadres of services under General Transfer Policy, with a direction to relieve the transferees on or before 19.07.2022, by making local arrangements and report compliance.

2. Management has noted that some of the employees were not yet relieved by the controlling officers at the present place of working, even after one month of issuing the orders, depriving the transferees to join at the place of posting on transfer. Further some of the transferees have not reported at the place of posting issued even after relief. Necessary action deemed fit will be initiated against the employees who were relieved but not reported. The non-assumption and non-relief of transferees is causing dis-array of functions in some of the stations. Hence, the concerned Station Heads and Functional Heads are hereby instructed to issue relief orders to the transferees by making local arrangements excluding the persons as mentioned in the ref (4) cited above and to communicate the instructions to the transferees to report at the place of posting.

3. The status of relief of the transferees may be intimated to this office by mail immediately for appraising the same to Managing Director.
