ORDER:

After careful consideration, the APGENCO in exercise of the powers conferred to in Regulation-41 of APSEB Service Regulations Part-II as adopted by APGENCO and Rule-7 of the A.P. Electricity Reforms (transfer scheme) Rules 1999 hereby issues the following Amendments to Annexure-III and Annexure VI of APSEB Service Regulations Part-III.

P&G Service

Deputy Secretary:

AMENDMENT-1

For the words occurred in Column (4) against the post of "Deputy Secretary" in Annexure VI of Part-III of APSEB Service Regulations "Assistant Secretary in P&G Service with not less than 5 years".

Substitute: "An approved probationer in the cadre of Assistant Secretary".

Personnel Officer:

AMENDMENT-2

For the words occurred in Clause (5) under Column (4) against the post of Personnel Officer by promotion in Annexure VI of Part-III of APSEB Service Regulations "Must have rendered a minimum regular service of 10 years as JPO/Senior Steno".

Substitute: "Must have rendered a minimum regular service of 7 years as JPO/Senior Steno".

Accounts Service

FA&CCA:

AMENDMENT-1

For "the words occurred in Column (3) against by promotions under column 2 for the post of FA&CCA in Annexure III of Part-III of APSEB Service Regulations "Must have experience in the accounts organization of the Electricity Board for a period of not less than fifteen years".

Substitute: "Approved probationer in the cadre of Deputy Chief Controller of Accounts".

Dy & CCA:

AMENDMENT-2

For "the words occurred in Clause (3) under Column (3) against by promotion under column 2 for the post of Dy. CCA in Annexure III of Part-III of APSEB Service Regulations "The Senior Accounts Officer" should have at least 20 years of service as Assistant Accounts Officer and above of which at least 2 years shall be as Senior Accounts Officer".

Substitute: "Approved probationer in the cadre of Senior Accounts Officer".

Senior Accounts Officer:

AMENDMENT-3

For "the words occurred in Column (3) against the post of Senior Accounts Officer in Annexure III of Part-III of APSEB Service Regulations "B.A or B.Sc or B.Com or any commercial degree of any recognized Indian University or any other equivalent qualification and must have had experience in Accounts organization in the Board for a period of not less than 10 years of which five years must be in the category of Accounts Officer including atleast one year as Accounts Officer or Assistant Accounts Officer in charge of System Accounts. This condition of one year service in system Accounts may be relaxed in deserving cases. Provided that the Accounts Officer who have put in 10 years of service in the category of AAO and AO together duly exempting them from possessing graduation qualification ^{and} experience required for promotion as SAO in the order of seniority, shall be considered for promotion as SAO for a period of one year from 01.05.1989."

Substitute: "B.A or B.Sc or B.Com. or any commercial degree of any recognized university or any other equivalent qualification and must have had experience of not less than 5 years as Accounts Officer".

4. Junior Accounts Officer:

AMENDMENT-4

For "the words occurred in Column(3) against by promotions under Column(2) for the post of JAO in Annexure III of Part-III of APSEB Service Regulations "The UDC's and UD/ Stenos in the APSEB Accounts Service with at least 5 years regular service as UDC/UD Steno in Accounts Service".

Substitute: "Approved probationer in the cadre of UDC/UD steno".

6. L.D.C:AMENDMENT-6

For the words occurred in Column (3) against the post of L.D.C in Annexure-III of Part-III of APSEB Service Regulations.

By transfer:- "Must hold the degree of B.A or B.Sc or B.Com of any university in India established or incorporated by or under a Central Act, Provincial Act or a State Act, or any equivalent qualification. By conversion of approved probationers in the category of Typists and Steno Typists in the same class of service".

Substitute: "Appointment by transfer".

- (a) Any in service candidate working in any service.
- (b) Must hold the degree of B.A or B.Sc or B.Com; of any university in India established or incorporated by or under Central Act, Provincial Act or a State Act or any equivalent qualification.
- (c) Must pass in the screening test to be conducted by the department once in a year.
- (d) The appointment by transfer to the post of LDC shall be subject to availability of posts.
- (e) Must be an approved probationer in the cadre from which the appointment by transfer is being made.

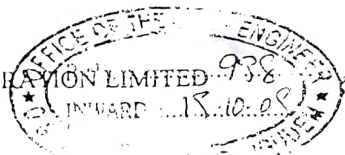

APGENCO - Accounts Service - Appointment of L.D. Clerks on appointment by transfer - Certain Instructions/Guidelines on conducting of Screening Test - Orders - Issued.

G.O.O.No.281/JS(Per)/2009.

Read the following:-

G.O.O.No.531/JS(Per)/2008, dtd.29.01.09.

ORDER:

1. In the reference read above, certain amendments to the Service Regulations were issued wherein it was inter-alia ordered against the Amendment-6 i.e., appointment by transfer to the post of L.D. Clerk that the candidates working in any service should pass in the Screening Test to be conducted by the Department once in a year.

2. Accordingly, the matter has been examined and after careful consideration, the following Guidelines/Instructions are issued for appointment to the post of L.D. Clerk on appointment by transfer.

- i. Common Screening Test for all the Units shall be conducted by the Chief Engineer/Training Institute, Dr.NTTTS, Ibrahimpatnam.
- ii. The Screening Test shall be conducted once in a year i.e., in the month of September/October of every year for the vacancies notified upto 31st August of that year. The merit list shall be operated for the vacancies notified only.
- iii. The Screening Test shall consist of two parts viz., (A) Written Examination for 90 marks and (B) Oral Interview for 10 marks.

Allocation of marks for written examination shall be as follows:

- a. Essay writing in English (200 words) → 20 marks
- b. Simple Arithmetic → 40 marks
- c. About the Organization, General Knowledge & Computer skills in basics. → 30 marks
- iv. Assess the computer knowledge of the candidates in terms of orders issued in the G.O.O.No.316/JS(Per)/08, dtd.29.02.08.
- v. Merit list drawn after the Screening Test is the base for selection and for fixing the seniority in the cadre of L.D. Clerk.
- vi. Merit list shall be unit wise as L.D. Clerk post is unit based. Screening Test/Written Test paper will be prepared and evaluated by the Chief Engineer/Training in consultation with Deputy Chief Controller of Accounts(Accounts) & Deputy Secretary (Estt)/VS/Hyd.
- vii. The Deputy Chief Controller of Accounts (Accounts) and Deputy Secretary(Estt) from Corporate Office shall be deputed as observers to the Screening Test.

3. The following Selection Committees are constituted for conducting the oral test:
