Sub:- APGENCO – Pension – Applicability of the revised period for Enhanced Family Pension payable to their dependents clarification issued by GoAP – Adoption – Reg.

In the reference 2nd cited, the GoAP at (item No-16) has ordered that if a Government servant dies while in service, the enhanced family pension is to be paid to his dependents for a period up to 10 years or upto the date on which he/she would have attained the age of 67 years, had he/she survived, whichever is earlier. In case of death after retirement the enhanced family pension should be payable for a period of seven (7) years or up to the date on which he/she would have attained the age of 67 years, had he/she survived, whichever is earlier. The same was adopted by APGENCO vide reference 3rd cited.

2. The Finance Department, GoAP vide reference 4th cited, have issued certain clarification to G.O.Ms.No.2, Finance (HR-III-Pension, GPF) Dept, Dt.17.01.2022 on the subject matter.

3. Accordingly, APGENCO hereby adopts the clarification issued by GoAP vide reference 4th cited. All the Drawing and Disbursing Officers are directed to follow the above clarification in reference 4th cited scrupulously.

The attention is invited on the subject and references cited.

2. The Director of Treasuries and Accounts in the references 1st & 2nd cited has stated that regarding the revised period of Enhance Family Pension orders have been issued vide G.O. 3rd cited but expressed that there is ambiguity on applicability and on effective date and requested to issue clarification on the matter.

3. In G.O MS.NO.2 Finance(HR.III-Pension,(GPF) Dept, Dt:17.01.2022 following orders have been issued regarding Enhance Family Pension:

" If a government servant dies while in service , the enhanced family pension is to be paid to his dependants for a period up to 10years or up to the date on which he/she would have attained the age of 67 yrs , had he/she survived, whichever is earlier. In case of death after retirement the enhanced family pension should be payable for a period of (7) years or up to the date on which he /she would have attained the age of 67 years , had he/she survived, whichever is earlier"

4. After careful examination of the matter hereby clarified that the effective date for applicability of revised period for enhanced family pension to be paid to the dependents as laid down in G.O.Ms.No.2, Fin(HR.III, Pen.& GPF) Dept. dt. 17.01.2022 in the event of death of an employee while in service/ as a Service Pensioner is on or after the effective date of the PRC i.e, 01.07.2018.
