Hence, all the Station Heads/Functional Heads and EPF Authorised Signatories of APGENCO are requested to obtain the Joint Option Forms from the willing individual Employees/Retired Employees who are willing for contribution to Employees' Pension Scheme 1995 and take necessary steps to submit the same through online portal [www.epfindia.gov.in/site\\_en/index.php](http://www.epfindia.gov.in/site_en/index.php) as per the guidelines/modalities issued by the Employee Provident Fund Organisation of India on or before 30.04.2023.
