In the reference cited, APGENCO has issued orders for coverage of Group Janata Personal Accident (GJPA) Policy sum assured of Rs.1,00,000/- each in respect of APGENCO regular employees for a period of Three(03) years i.e., from 12.12.2020 to 11.12.2023 with premium of Rs.149.85/- (including GST 18%) through M/s. The Oriental Insurance Company Limited, Visakhapatnam.

2. As a part of social security, the APGENCO has decided to extend the benefit of coverage of Group Personnel Accident Policy sum assured of Rs.10,00,000/- (Rupees Ten Lakhs Only) in place of Group Janata Personal Accident (GJPA) Policy to each employee with self contribution of annual premium of Rs.270/- through M/s. Reliance General Insurance Company Ltd for the year 2023-2024. The premium amount shall be recovered from the respective employee salary.

3. Hence, the employees who un-willing to avail the said benefit are requested to submit their names to their respective controlling officers on or before 25th of May 2023.

4. All the Station Heads/Functional Heads of APGENCO are requested to take necessary action and furnish the data in respect of un-willing candidates to avail said policy to this office on or before 31.05.2023.

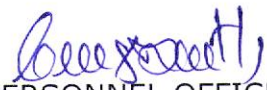

- 2) Letter dated.01-12-2020 received from the Sr. Divisional Manager, M/s The Oriental Insurance Co. Ltd., Visakhapatnam.

O R D E R:

In the G.O.O. cited above, sanction was accorded to M/s The Oriental Insurance Company Limited, Divisional Office-III, Visakhapatnam for coverage of Group Janata Personal Accident (GJPA) Policy for a further renewal period of Three (03) Years with a Single Premium Rate of Rs.166.50/- (Rupees One Hundred and Sixty Six and Fifty Paise Only) per Employee and directs that the Policy shall come in to force from 01-12-2017. This Policy covers the APGENCO Employees against the risk due to accident not only during the course of employment but also outside such as road accidents, burns due to fire, drowning in water, death due to current shock, snake bite, dog bite, riots, actions of militants and murders and also total or partial permanent disability sustained in accidents.

2) The period of GJPA Policy mentioned in para-1 above expires by 11.12.2020.

3) The Senior Divisional Manager, M/s The Oriental Insurance Company Limited, Divisional Office-III, Visakhapatnam vide reference 2nd cited, has come forward for renewal of the said GJPA Policy for a further period of Three (03) Years with a Single Premium of Rs.149-85 (Rupees One Hundred and Forty Nine and Eighty Five Paise Only) per Employee, with the same Terms & Conditions as laid down in GOO 1st cited.

4) The Policy offered by M/s The Oriental Insurance Company Limited, Divisional Office-III, Visakhapatnam covers the APGENCO Employees against risk on 24 Hours basis whether the employees are on duty or otherwise, covering accidental death/injuries due to electrocution, accidental falls, road accidents, explosions, drowning, snake bite, dog bite, riots, actions of militants and murders.

5) After careful consideration, the APGENCO hereby has considered and accepts the offer of M/s The Oriental Insurance Company Limited, Divisional Office-III, Visakhapatnam for renewal of further Three (03) Years Group Janata Personal Accident (GJPA) Policy with a Single Premium of Rs.149-85 (Rupees One Hundred and Forty Nine and Eighty Five Paise Only) per Employee WITHOUT Agency Services and directs that the GJPA Policy shall come into force from 12.12.2020 and continue till 11.12.2023 and M/s The Oriental Insurance Company Limited shall cover the risk of employees of APGENCO from 12.12.2020 on the Terms & Conditions mentioned in paras 2 & 3 above. The present GJPA Policy covers all monthly paid employees of the APGENCO. The amounts of insurance cover payable under the said policy are as follows:-

6) The Pay Officer, APGENCO., Vidyut Soudha, Vijayawada is requested to arrange the payment of Rs.8,63,885-00 (Rupees Eight Lakhs Sixty Three Thousand Eight Hundred and Eighty Five Only) (i.e., 5765 Employees (approximately) X Rs.149.85/- Single Premium) to M/s The Oriental Insurance Company Limited, Divisional Office-III, Visakhapatnam towards GJPA Policy for APGENCO Employees for the Period of Three (03) Years i.e., from 12.12.2020 to 11.12.2023.

7) All the Pay Drawing Officers/APGENCO are requested to enforce this scheme as compulsory and recovery may be made from the salaries of the employees for the month of DECEMBER 2020 PAYABLE IN JANUARY 2021 and for accounting purpose book adjustment entry may be made without making any actual payment to the insurance company.
