Under Regulation 14 (a) (1) of A.P.S.E.B. SRs Part-II, as adopted, the NINETEEN (19 No's) APGENCO Constables as annexed to this order are promoted temporarily to act as APGENCO Head Constables with effect from the date of joining.

2. The promotion ordered in para-1 above is purely temporary and liable to be terminated at any time without notice and without assigning any reasons thereto.

3. The NINETEEN (19 No's) APGENCO Constables on temporary promotion as APGENCO Head Constables are posted to the places noted against their names in the Annexure appended to this order. They are directed to join at the place of posting within 15 days time. No request for change of posting or sanction of leave will be entertained.

4. If they fail to join or evade joining within 15 days from the date of receipt of this order or proceeded on leave, their promotion right shall be forfeited for the current panel and the name of the candidate shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancies, in terms of orders issued in G.O.O.No.231/JS (Per)/2008, dt.02.08.2008. In addition, necessary departmental disciplinary action as deemed fit shall also be initiated against them for non-compliance of orders issued above.

5. The Concerned Controlling Officers are requested to relieve the promotee so as to enable them to join at the place of posting ordered.
