Under Regulation 14 (a) (1) of A.P.S.E.B. SRs Part-II, as adopted, Sri B.C.S.N. Karthik, Assistant is promoted temporarily to act as Junior Personnel Officer with effect from the date of joining.

2. The promotion ordered in para-1 above is purely temporary and liable to be terminated at any time without notice and without assigning any reasons thereto.

3. The promotion ordered in para-1 above is subject to the result/review of final allocation of state cadre employees between APGENCO & TSGENCO that may occur as per the A.P. Reorganization Act, 2014, besides subject to the outcome of Batch of M.A. No.1286/2020 & Batch C.A. No.11435/2018, pending before the Supreme Court of Judicature.

4. Sri B.C.S.N. Karthik, Assistant on promotion as Junior Personnel Officer is transferred and posted to the Peshi of the Joint Secretary (Per) in the existing vacancy.

5. The concerned controlling officer is requested to relieve the above Assistant by making the local arrangements within 15 days from the date of issue of this order, otherwise the promotee shall be treated as deemed to have been relieved of his/her duties after expiry of the stipulated period.

6. Sri B.C.S.N. Karthik, Assistant is directed to assume charge on promotion as Junior Personnel Officer at the place of posting ordered. If he fails to join or evade joining within the stipulated period or proceeded on leave from the date of receipt of this order, his promotion right shall be forfeited for the current panel and the name of the candidate shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancies, in terms of orders issued in G.O.O.No.231/JS(Per)/2008, Date:02.08.2008. Necessary departmental disciplinary action as deemed fit shall also be initiated against him for non-compliance of orders issued above. No request for change of posting or sanction of leave will be entertained.
