ORDER:

In the G.O.1st read above, the Government of Andhra Pradesh in exercise of the powers conferred by sub-sections (1) and (3) of section 3 of the Andhra Pradesh Essential Services Maintenance Act, 1971 (A.P. Act 20 of 1971), prohibited the strikes in all the services under the Transmission Corporation of Andhra Pradesh Ltd., three Distribution Companies viz., APEPDCL, APSPDCL & APCPDCL and APGENCO in Andhra Pradesh, for a period of six (6) months with effect from 10.05.2025 and the same is going to be lapsed by 09.11.2025.

2. In the reference 2nd read above, Chairman & Managing Director, APTRANSCO has requested the Government to extend the orders of prohibiting the strikes in APTRANSCO, APGENCO and three (3) DISCOMs for a further period of (6) months with effect from 10.11.2025.

3. Accordingly, the following Notification will be published in an Extraordinary issue of Andhra Pradesh Gazette, dated.22.10.2025.

NOTIFICATION

Whereas, the Government have already declared any service under the Transmission Corporation of Andhra Pradesh Ltd., and three Distribution Companies (APEPDCL, APSPDCL & APCPDCL) and APGENCO as an essential service as defined in sub-clause (v) of clause (a) of sub-section (1) of section 2 of the Andhra Pradesh Essential Services Maintenance Act, 1971, (A.P.Act No.20 of 1971);

And whereas, the Government have satisfied that it is necessary and expedient to prohibit strikes in public interest, in any services under the Transmission Corporation of Andhra Pradesh Ltd., and three Distribution Companies (APEPDCL, APSPDCL & APCPDCL) and APGENCO for a period of six (6) months;
