The Chief Engineer/O&M/Dr.NTTPS has forwarded the job proposal vide reference 5th cited for providing employment under Compassionate scheme to Sri. D. Chandra Mouli S/o.Late (Sri) D. Muni Swamy, Ex-FM Gr-IV/ Dr.NTTPS.

2. After careful consideration and in terms of orders issued in the reference 1st & 6th read above, hereby accorded approval to Sri. D. Chandra Mouli S/o.Late (Sri) .D. Muni Swamy, Ex-FM Gr-IV/ Dr.NTTPS for appointment to the post of '**Office Subordinate**' at Dr.NTTPS under compassionate grounds.

3. Being the appointing authority, the Chief Engineer/O&M/ Dr.NTTPS is requested to issue the appointment order by ensuring the following:

- a) The appointment orders shall be issued against in the vacancy of JPA until the vacancy arises in the cadre of Office Subordinate.
- b) The appointment order shall be issued only after recovery of pending loans/dues, if any, along with applicable interest and obtaining final No Dues Certificate from the concerned authority.
- c) The appointment order shall be issued only after production of physical fitness certificate issued by Medical Officer of the rank not less than that of Asst. Civil Surgeon.
- d) Necessary Affidavit with appropriate Stamp Paper attested by Notary or Oath Commissioner in the format prescribed by the Board in B.P.Ms.No.216, Dt: 09.03.1990 shall be obtained before issue of appointment orders. The contents of the affidavit shall be recorded in his Service Register at the earliest.

4. The following terms and conditions shall be incorporated in the appointment order.

- a) A clause may be incorporated that "if any information/documentation furnished by him for the purpose of getting appointment under compassionate appointments is found to be false or misleading at a later date, his services shall be liable for termination without any notice and without assigning any reasons thereof. In addition, he is also liable for criminal prosecution for the act of furnishing false or misleading information/ documentation".

- b) The candidate shall be governed by the provisions of EPF & MP Act 1952 and the employees PF Scheme in terms of orders issued in G.O.O.No.708/ GM (Adm)/2002,dt. 06.02.2003.
- c) The candidate shall be governed by the Rules and Regulations of APGENCO that are being framed from time to time.
- d) The Tripartite agreement entered into between APSEB, Govt. of AP and Employees Associations is not applicable to him and he shall at no stage be entitled to claim any right whatsoever arising out of the said Tripartite Agreement. An undertaking to this effect should be obtained from him at the time of joining duty and record the same in the Service Register.
- e) The appointment is provisional and is liable for termination at any time without notice and without assigning any reasons.
- f) The appointment order is subject to verification of Character and Antecedents. The candidate shall fill in the attestation forms enclosed in quadruplicate and submit to the concerned officer at the time of joining duty.

5. Original Certificates are verified and necessary sheets are sent herewith for placing in her personal file.

6. It is directed to ensure the genuinity of caste and relevant educational certificates produced by the candidate before regularisation of services.

7. The Chief Engineer/O&M/ Dr.NTTPS is requested to issue appointment orders to Sri. D. Chandra Mouli S/o.Late (Sri) .D. Muni Swamy, Ex-FM Gr-IV/ Dr.NTTPS within 10 days positively as per the rules in vogue.
