The Chief Engineer/O&M/Dr.MVR RTPP & Chief Engineer/O&M/Dr.NTTTPS has forwarded certain job proposals vide references 3rd to 11th cited for providing employment to the dependent of deceased employee while in service under Compassionate scheme.

2. After careful consideration and in terms of orders issued in the references 1st to 3rd & 12th read above, hereby accorded approval to the 8Nos dependent of deceased employees whose names are mentioned in the annexure appended to this memo for appointment under compassionate grounds against the existing vacancy subject to the following conditions:

- a) Original Certificates with regard to Educational Qualifications, Date of Birth, Photo Identification Certificate, Death Certificate, Legal Heir Certificate, No Earning Member Certificate etc., should be verified thoroughly.
- b) A declaration from the dependent furnishing the details of all the family members, sex, age, qualifications, occupation and addresses etc., should be obtained. If any earning member is available in the family, appointment orders shall not be issued.
- c) In the appointment orders, a clause may be incorporated that "if any information furnished by him in the proposals is found to be false, at a later date her services shall be liable for termination without any notice and without assigning any reasons thereof and further she shall be liable for punishment".

- d) In case any loans are outstanding, the same may be recovered in full, along with the interest thereon before issue of appointment orders.
- e) Necessary Affidavit with appropriate Stamp Paper attested by Notary or Oath Commissioner in the format prescribed by the Board in B.P.Ms.No.216, Dt: 09.03.1990 shall be obtained before issue of appointment orders. After issuing appointment order, the contents of the affidavit shall be recorded in his/her Service Register.
- f) Appointment should not be given to dependents of deceased trainee employees.
- g) Verification of character and Antecedents should be done.
- h) The candidate shall be governed only by the provisions of EPF & MP Act 1952 and the employees PF Scheme in terms of orders issued in G.O.O.No.708/ GM(Adm) /2002, dt.06.02.2003.
- i) The Chief General Manager (Adm,IS&ERP) is requested to exercise the power of Appointment when she is when they are empowered to do so:
- j) The candidates should be insisted to produce three certificates from three persons of respectable status and/ or holding responsible positions verifying his/her conduct and character.
- k) The candidates shall be governed by the Rule and Regulations of APGENCO that are being framed from time to time.
- l) The Tripartite agreement entered into between APSEB, Govt. of AP and Employees Associations is not applicable to him/her and he/she shall at no stage be entitled to claim any right whatsoever arising out of the said Tripartite Agreement. An undertaking to this effect should be obtained from him/her at the time of joining duty and record the same in the Service Register.
- m) The appointment orders shall be given subject to production of physical fitness certificate issued by Medical Officer of the rank not less than that of Asst. Civil Surgeon.

3) The Chief General Manager (Adm,IS&ERP)/APGENCO is requested to follow the Rules and Regulations issued by APGENCO from time to time and appoint the individuals mentioned in the annexure appended to this memo within 10 days positively as per the rules in vogue.
