In the references cited, as a part of social security the Group Personal Accident Policy has been covered to the regular employees in APGENCO for the period 2025-26 for sum of Rs.50,00,000/- (Rupees Fifty Lakhs only) with a premium of Rs.915/- including GST with self-contribution and the same is going to be expired on 19.07.2026.

2. Now, it has been extended the benefit of coverage under Group Personnel Accident Policy for the year 2026-2027 for sum assured of Rs.50,00,000/- (Rupees Fifty Lakhs Only) with annual premium of Rs.1645/- (including GST) to each employee on self-contribution basis, considering the inflationary impact and the recent claims under the existing GPA Policy.

3. Hence, all regular employees who are not willing to avail themselves of the above insurance coverage are requested to intimate their un-willingness to their respective controlling officers on or before 12th of July 2026.

4. All Station Heads/Functional Heads of APGENCO are requested to take necessary action in the matter and furnish the particulars of employees who are un-willing to avail the said policy to this office on or before 12.07.2026 through e-mail legal@apgenco.gov.in, to facilitate necessary action.
