ORDER:

As a part of social security measure, the Group Personnel Accident Policy for sum assured of Rs.50,00,000/-(Rupees Fifty Lakhs only) for the period 2025-26 has been extended for a further period of one year i.e., from 2026-2027 to the regular employees working in APGENCO with self-contribution, considering the inflationary impact and recent claims under the existing GPA Policy.

2. In the reference 1st cited, M/s. United India Insurance Company Ltd., Vuyyuru, Krishna Dist., through Trailblazer Broking Services has offered lowest premium of Rs.1645/- (Rupees One thousand Six hundred and Forty Five only), including GST per employee for providing Insurance Coverage under Group Personal Accident Policy for sum assured of Rs.50,00,000/-(Rupees Fifty Lakhs only) each to the 5043 No's regular employees for a period of 12 months i.e., from 20.07.2026 to 19.07.2027.

3. After careful consideration, sanction is hereby accorded for an amount of Rs.82,95,735/- (Rupees Eighty Two lakhs Ninety Five thousands Seven hundred and Thirty Five only) with GST 18% towards Insurance Premium for coverage under Group Personal Accident Policy to the 5043 No's regular employees for a period of One year i.e., from 20.07.2026 to 19.07.2027 as per list enclosed. The amount of Rs.1,645/- towards premium shall be recovered from the respective beneficiary employees in the pay bill of July'2026.

4. The Pay Officer/APGENCO/VS/VJA is requested to arrange the payment of the sanctioned amount mentioned in Para-3 by way of cheque/NEFT drawn in favour of M/s. The United India Insurance Company Ltd., Vuyyuru, Krishna Dist., PAN No: AAACU5552C and GST 37AAACU5552C1ZI.

5. All the DDO/Pay Drawing officers are requested to recover the said premium amount from the respective beneficiary employees in the pay bill of July'2026 and also take necessary steps to recover the same in respect of employees who deputed to other organisations.

6. If any employee contribution could not be recovered in the pay bills of said month for the reasons such as non-drawl of salary due to proceeding on leave etc., the contributions are shall be recovered from the next immediate duty pay bill.

7. The sanction is registered at S.No.03 for the year 2026-2027.
