Public Services – Government Employees – Revised Pay Scales 2022 – House Rent Allowance (HRA) – Extension of HRA @ 24% of the basic pay subject to a maximum of Rs. 25,000/- to all employees of Secretariat and Heads of Departments up to June, 2027 or till implementation of 12th PRC or till the provision of quarters by CRDA in the Amaravati, whichever is earlier – Orders – Issued.

Government issued Comprehensive Orders on implementation of 11th PRC, Revised Pay Scales, 2022, in the reference 1st read above. In the reference 2nd read above, Government have revised the rates of HRA @ 24% of the basic pay subject to a maximum of Rs. 25,000/- to all employees of Secretariat and Heads of Departments (HoDs) w.e.f. 01.01.2022 and continued up to June, 2024. The same has been extended up to 30.06.2026 in the references 3rd and 4th read above.

2. The Employees' Associations have represented to continue the HRA @ 24% beyond June, 2026 for the Secretariat and HoD employees, as the premises listed in the GO 4th read above, still exists and the 12th PRC is yet to give its recommendations on the subject.

3. Government, after careful consideration of the entire matter and keeping in view of the welfare of the employees, hereby decided to extend the provision of HRA at @ 24% of the basic pay subject to a maximum of Rs. 25,000/- to all employees working in Secretariat and Heads of Departments for one more year w.e.f. 01.07.2026 i.e. up to June, 2027 **(or)** till implementation of 12th PRC **(or)** till the provision of quarters by CRDA in Amaravati, whichever is earlier.
