ORDER

The APGENCO after careful consideration and in partial modification of the orders issued in the reference 1st cited hereby issued the orders for enhancement of appearance fee from Rs. 50,000/- to Rs. 1,00,000/- + Rs.10,000/- towards clerkage @10% on fee to the AORs for appearing before Hon'ble Supreme Court on behalf of APGENCO as follows:

(i) For Single Cases

2) The Functional Heads and Station Heads of APGENCO are requested to ensure that the AORs engaged shall abide by the above fee structure they shall be engaged/empanelled in the cases before Hon'ble Supreme Court accordingly.

3) The other terms and conditions stipulated in the reference 1st cited remain unaltered.

4) This order shall come into force with immediate effect. The pending bills shall be settled accordingly. The claims already settled will not be reopened.
