ORDER:

In pursuance of the Policy Guidelines issued vide reference 1st cited for engagement of Retired Revenue Officers/Staff to provide assistance in Land Acquisition at ROs/PIUs, and with the approval of the Competent Authority vide reference 3rd & 4th cited, the following Retired Tahsildars are hereby engaged as Estate Officers on contract basis for assisting in Estate / Land Acquisition /Alienation matters in the following Power Plants of APGENCO:

2. Scope of work:

The Estate Officers shall assist the respective Plant Authorities in the following matters:

- Land Acquisition/Alienation cases
- Estate management matters
- Liaison with Revenue Department officials to alienate Government lands in the name of APGENCO i.e., Dr. NTTPS/Ibrahimpattam & Dr.M.V.R. RTPP/ Kalamalla, respectively.
- Court cases relating to land matters
- Prevention/removal of encroachments on APGENCO lands.
- Verifying revenue records for Adangal entry of all lands of Dr. NTTPS & Dr.M.V.R. RTPP.
- Any other correspondence with revenue department based on necessity.
- Any other suggestions/recommendations to the concerned field Engineer for expediting the process of lands conversion.
- Maintenance of land records and discharge of related duties as entrusted by the competent authority from time to time.
- Transfer of title deeds in favour of APGENCO wherever required.

3. **Terms and Conditions:**

- i. The engagement is purely on temporary / contract basis and shall not confer any right for regular appointment / absorption in APGENCO.
 - ii. The engagement shall be for a period of **one (01) year** from the date of joining duty, subject to requirement and satisfactory performance, or until further orders, whichever is earlier.
 - iii. The engaged Estate Officers shall be paid a consolidated remuneration of **Rs. 65,000/- (Rupees Sixty-Five Thousand only)** per month.
 - iv. They shall also be eligible for reimbursement of miscellaneous expenses up to **Rs. 10,000/- (Rupees Ten Thousand only)** per month towards mobile charges and other incidental official expenses, subject to submission of claims / certification as per rules.
 - v. Vehicle facilities are provided separately for official purposes, subject to availability and as decided by the concerned Plant Authorities.
 - vi. The leave entitlement shall be as follows:
 - o All declared working holidays as applicable to offices/units concerned.
 - o 08 Casual Leaves (CLs) in a calendar year.
 - o 15 Paid Sick Leaves in a calendar year.
 - o No un-availed leave shall be carried forward to the next period of extension, if any.
 - vii. The engaged personnel shall maintain absolute integrity, devotion to duty and confidentiality in discharge of official duties.
 - viii. The engagement is liable for termination at any time by either side by giving notice as prescribed in the policy guidelines / terms approved by APGENCO.
 - ix. The individuals shall report for duty before the respective Chief Engineers concerned within 15 days from the date of receipt of these orders and submit joining reports.
 - x. The Chief Engineers / Unit Heads concerned shall lookout the performance of the engaged Estate Officers and send compliance reports to Corporate Office.
