4. This bill is audited by CGM(A&T) dt.16.01.2026 and orders issued with the approval of Director(HR&IR)/APGENCO.

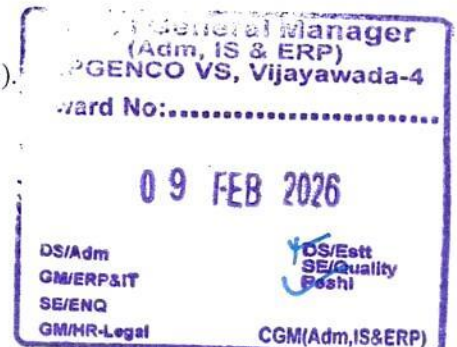
