Order:

Three-member Arbitral Tribunal has been constituted with Justice B.Sudershan Reddy, Former Judge, Supreme Court of India as arbitrator of M/s. Tecpro systems Ltd., Justice Sri Mukundakam Sharma, Former Judge, Supreme Court of India, as arbitrator of APGENCO and Hon'ble Justice Sri R.V. Raveendran, Former Judge, Supreme Court of India, as the Presiding Arbitrator in the matter of disputes between APGENCO and M/s.Tecpro system Ltd.

2) In the reference 2nd cited, the Chief Engineer/Generation/APGENCO, V.S., has forwarded the e-office note approval for releasing of fee of Rs.5,00,000/- to each Arbitrator and requested to arrange the payment to the above 3 nos Arbitrators of the Arbitration Tribunal.

3) After careful consideration, and in exercise of delegation of powers ordered in G.O.O.No.129/JS(Per)/2016, dated 15.07.2016, sanction is hereby accorded for a total amount of **Rs.15,00,000/-** (Rupees Fifteen Lakhs only) towards the fees of the Arbitral Tribunal of 3 Nos Arbitrators i.e., i) Rs.5,00,000/- to Justice Sri Raja Varadarajulu Raveendran (Or R.V. Raveendran), ii) Rs.5,00,000/- to Justice Sri Mukundakam Sharma and iii) Rs.5,00,000/- to Justice Sri B.Sudershan Reddy. The applicable GST shall be paid by APGENCO on the said payments.

4) The Pay Officer/APGENCO/V.S. is requested to arrange payment of the amounts sanctioned in Para-3 above as follows:

- i) Justice Sri Raja Varadarajulu Raveendran (Justice R.V. Raveendran)
– by way of Cheque/RTGS;
- ii) Justice Sri Mukundakam Sharma – by way of Cheque/RTGS; and
- iii) Justice Sri B. Sudershan Reddy – by way of Cheque only, as requested, instead of bank transfer.
