ORDER:

In the reference 9th cited, APSEB Engineers Association & APSEB AEE's Association has requested to issue necessary instructions to the concerned to deduct for an amount of Rs.1000/- (Rupees One Thousand only) per month from the salaries of all Engineers from AEE cadre to ED/CE in Engineering services in APGENCO from the month of March' 2026, April' 2026 & May '2026 salaries payable in April' 2026, May '2026 & June '2026 and deposit the above amounts to the Accounts of the dependents of the demised Engineers.

2. After careful examination, APGENCO hereby accords approval for deduction of Rs.1000/- (One Thousand only) each per month from the salaries of all Engineers from AEE cadre to Chief Engineer cadre in Engineering Services of APGENCO. The said deduction shall be effected for the months of March' 2026, April' 2026 & May '2026 salaries payable in April' 2026, May '2026 & June '2026 and to remit the same to the Bank Accounts of the dependents of the deceased Engineers @ one month's contribution to one (1) bereaved family respectively in the sequence as mentioned in the below table.

4. If any employee's contribution could not be recovered in the pay bills of said months for the reasons such as non-drawl of salary due to proceeding on leave etc., the contributions shall be recovered from the next immediate duty pay bill.
5. The amounts so credited are to be shown distinctly in the trial balance without clubbing with any other remittances.
6. All the Drawing Officers of APGENCO are directed to follow the instructions scrupulously.
7. The AO(CPR)/APGENCO/VS/VJA is authorized to exercised the above orders issued at para 2 and intimate the remittance details along with recovery particulars to the APSEB Engineers' Association and to the beneficiaries.
