ORDER:

- d) APSPDCL shall remit the gratuity contribution in respect of Sri B. Ramesh Reddy, AEE, for the service rendered by him in APSPDCL up to the date of his relief, to APGENCO, in accordance with the applicable rules/orders, as the liability under the Payment of Gratuity Act, 1972, shall be borne by APGENCO upon his permanent absorption.
- e) The accrued leave to the credit of Sri B. Ramesh Reddy, AEE, pertaining to his service in APSPDCL shall be carried forward and the corresponding leave salary contribution shall be remitted by APSPDCL to APGENCO, as per the applicable rules/orders.
- 3) Sri B. Ramesh Reddy, AEE, who has been relieved from APSPDCL w.e.f. 06.08.2026 A.N is directed to report to the Chief Engineer/O&M/Dr. MVR RTPP, APGENCO for further posting.
- 4) The Chief Engineer/O&M/Dr. MVR RTPP is directed to issue necessary reposting orders to Sri B. Ramesh Reddy, AEE and report compliance to the undersigned.
- 5) Sri B. Ramesh Reddy, AEE, shall not be entitled to Travelling Allowance (TTA) or joining time, as the posting to Dr. MVR RTPP/APGENCO is made at his request in connection with his permanent absorption in APGENCO.
