ORDER:

In the G.O.O. 1st read above, Sri R.Mani Kiran was appointed as Assistant Company Secretary on contract basis initially for a period of two years with APGENCO w.e.from 26.09.2016 and two years period completed by 25.09.2018 A.N. In G.O.O. 2nd read above, his contract period was extended for a further period of two years w.e.from 26.09.2018 F.N. to 25.09.2020 A.N. with a consolidated pay of Rs.40,000/- per month on the same terms & conditions. Thereafter, his tenure as Assistant Company Secretary (on contract basis) has been extended upto 25.09.2024 from time to time, and the consolidated pay of Rs.62,000/- per month is enhanced to Rs.80,000/- per month w.e.from 15.05.2024.
