ORDER:

In the reference 2nd cited, sanction has been accorded for coverage of Insurance under Group Personal Accident Policy to the 5152 Nos of regular employees for a period of 12 months (i.e.) from 20.07.2025 to 19.07.2026 at a total premium of Rs. 47,14,080/- (Rupees Forty Seven Lakhs Fourteen Thousand and Eighty only) with 18% GST payable to M/s. The Oriental Insurance company limited, Hyderabad. The premium amount of Rs.915/- shall be recovered from the respective beneficiary employees in the pay bill of July' 2025.

2. After careful examination, certain modification orders are hereby issued to recover the premium amount as per eligibility instead of Rs.915/- from the respective 200 Nos beneficiary employees (list enclosed) whose gross monthly salary is less than Rs.50,000/- under Group Personal Accident Policy for a sum insured of Rs.50,00,000/-. The applicable premium amount shall be recovered from the respective beneficiary employees in the pay bill of July' 2025 as per the statement enclosed.

3. All the DDO/Pay Drawing officers are requested to recover the said premium amount from the 200 Nos employees respective beneficiary employees (as per the list enclosed) in the pay bill of July' 2025 and also take necessary steps to recover the same in respect of employees who deputed to other organisations. The remaining terms and conditions mentioned in the G.O.O. 105, Dt. 17.07.2025 is unaltered.
