ORDER:

In the reference cited, Sri K. Satyanarayana, IRTS, Sr. Divisional Operations Manager /South Central Railways (Retd.), Vijayawada requested to give opportunity to serve APGENCO.

2. After careful consideration, Sri K. Satyanarayana, IRTS, Sr. Divisional Operations Manager /South Central Railways (Retd.), Vijayawada is hereby appointed as OSD, Coal Movement in APGENCO on contract basis with the following terms and conditions:

- (i) The contract appointment shall be initially for a period of one year from the date of assumption.
- (ii) His services are placed under the control of Director (Thermal), VS, VJA.
- (iii) He shall be paid remuneration of Rs. 1,10,000/- (Rupees one lakh ten thousand only) per month.
- (iv) APGENCO reserves the right to terminate contract period at any point of time.

Scope of work:

- (i) Coordinating with East Coast Railways, South Central Railways, South East Central Railways and South Eastern Railways for allotment of maximum number of rakes to Dr. NTPS, Dr.M.V.R. RTPP and SDSTPS/APPDCL.
- (ii) To pursue with Railways for timely movement of Rakes on day-to-day basis.
- (iii) To assist APGENCO and APPDCL for settlement of claims if any with Railways.
- (iv) To pursue with Railways to obtain maximum rebate on demurrage charges imposed and to co-ordinate with Railways to avoid congestion of rakes so as to minimize the demurrage charges.
- (v) To minimize the rebooking of rakes to other power plants so as to reduce rebooking charges etc.,
- (vi) He shall carry out any works assigned by the Management pertains to Rail movement.
