ORDER:

APGENCO Board vide its note dated 30.04.2024 accorded approval to appoint Sri Antony Raja, Ex-Director (Coal & Logistics)/APGENCO, as Consultant (Coal & Logistics), for a period of six months w.e.f 04.05.2024 or till Government of AP, finalizes new Director (Coal & Logistics) whichever is earlier.

2. Accordingly, Sri Antony Raja, is hereby appointed as Consultant (Coal & Logistics) for a period of six months w.e.f 04.05.2024 or till Government of AP, finalizes new Director (Coal & Logistics) whichever is earlier. The appointment is subject to the following terms and conditions:

- a) He shall be paid fixed remuneration of Rs.4,41,600 /- (Rupees Four lakh forty-one thousand six hundred only) per month.
- b) He shall be provided departmental accommodation on chargeable basis Rs.25,000/- per month. Further, water charges Rs.230/- and CC charges Rs.692/- shall be charged per month.
- c) Departmental Vehicle shall be provided on par with Directors of APGENCO.
- d) He shall be allowed TA & DA as applicable to Directors of APGENCO.

3. The Scope of work for the Consultant (Coal & Logistics) is as follows:

- a) To plan for sufficient quality Coal quantities and efficient logistics support for seamless supply of coal to Thermal Plants.
- b) To coordinate with Coal India Limited, SCCL and other coal companies for the supply of quality coal.
- c) To pursue with Ministry of Coal and Ministry of Railways, Govt. of India for allotting of coal rakes.
- d) Monitoring stocks at Paradeep, Kakinada, Krishnapatnam & Ennore ports. Deployment of Vessels in time.

- e) To monitor with Railway authorities to deploy and for allotment of rakes and its movement.
- f) Any other works as entrusted by the Managing Director/APGENCO.

4. He is directed to report to Managing Director, APGENCO. The Officers hitherto reporting to Director (Coal & Logistics) shall henceforth report to Consultant (Coal & Logistics).

5. He is directed to submit his acceptance of this order by signing and returning copy of this order. The return acceptance of this order shall be construed that he accepted the offer from APGENCO.
