APGENCO – Medical – Consideration of Bhadrachalam, Khammam Dist, Telangana Hospitals for Settlement of reimbursement Claims as a Special Case on par with Andhra Pradesh Hospitals – Orders - Issued.

ORDER:

In terms of the orders issued vide ref 1st cited read with 2nd cited, the recognized hospitals in Hyderabad will be continued as referral hospitals upto 01.12.2024 or until further orders received from the Govt., of AP, whichever is earlier.

2) It is observed that most of Employees/Pensioners & their dependent Family members and Family Pensioners of Sileru Complex & Donkarayi are belongs to Natives of erstwhile Khammam district and settled in the vicinity of the said District after retirement and undergoing treatment in the Hospitals located in Bhadrachalam, Khammam District, Telangana and submitting claims for reimbursement. Such claims are disallowed as Bhadrachalam is not part of the Andhra Pradesh as per A.P. Reorganization Act 2014.

3) After careful consideration, and keeping in view of the welfare of Employees/Pensioners and their dependents and Family Pensioners belonging to the Sileru Complex (LSHES, USHES, Donkarayi), it is hereby ordered that the reimbursement claims for the treatments obtained in the hospitals situated in Bhadrachalam, Khammam Dist pertaining to Employees/Pensioners and their dependents and Family Pensioners of Sileru Complex shall be settled on par with Claims being settled in the hospitals situated in Andhra Pradesh as a Special Case.
