ORDER:

In memo 3rd cited, Smt. Katta Aruna Kumari, W/o Late (Sri) L. Subrahmanyam, Ex-EE/ Civil/VS/ VJA was sanctioned an amount of Rs.4,00,000/- in General Ceiling as per Clause 11(i) of G.O.O. 1st cited, against medical reimbursement claim of Rs.56,00,000/-, for the treatment of "LUNG TRANSPLANTATION" taken to her husband at M/s.KIMS Hospitals, Secunderabad as inpatient during the period 21.01.2024 to 14.02.2024.

2. Aggrieved, vide reference 5th cited, Smt. Katta Aruna Kumari, W/o Late (Sri) L. Subrahmanyam, Ex-EE/ Civil/VS/VJA has represented that, she had paid the bill for an amount of Rs.56,00,000/- by taking debts from relatives and family friends, facing severe financial struggles because of the debts, thus requested to release as much as possible amount in his available ceiling limits, to ease her financial struggles, as a special case. The issue has placed before the APGENCO Board.

3) The APGENCO Board in its 203rd meeting held on 30.12.2024 has approved for sanction of balance eligible amount of Rs.24,95,039/- (Rupees Twenty four lakhs Ninety five thousand and Thirty Nine only) (i.e. Rs. 6,00,000/- (SFMS 2023-2024) + Rs.15,00,000/- (Major 3 spells) + 3,95,039/- (General)) stood at the credit of late (Sri) L. Subrahmanyam, Ex-EE(Civil) as on 28.10.2024 towards the medical expenses incurred towards LUNG TRANSPLANTATION of Late (Sri) L. Subrahmanyam, Ex-EE(Civil) in relaxation of the existing medical policy of APGENCO vide G.O.O.1st cited as a special case on humanitarian grounds.

4) Therefore, after careful consideration sanction is hereby accorded for payment of Rs.24,95,039/- (Rupees Twenty four lakhs Ninety five thousand and Thirty Nine only) to Smt. Katta Aruna Kumari W/o. late (Sri) L. Subrahmanyam, Ex-EE(Civil)/VS towards reimbursement of medical expenses incurred for the lifesaving surgery "LUNG TRANSPLANTATION" as a special case on humanitarian grounds.

5) The Accounts Officer(CPR)/VS/VJA is requested to arrange the payment of an amount of Rs.24,95,039/- (Rupees Twenty four lakhs Ninety five thousand and Thirty Nine only) (i.e. Rs. 6,00,000/- SFMS 23-24 + Rs.15,00,000/- Major 3 spells + 3,95,039/- General) and the same shall be debited from General & Major account No.450670 and SFMS account No.209620 accordingly.

6) As of now, the APGENCO has authorised cumulative amount of Rs.31,29,584/- [Rs.10,00,000/- General ceiling + Rs.6,00,000/- SFMS 2023-24 + Rs.5,00,000/- Major 1st spell + Rs. 5,00,000/- Major 2nd spell + Rs. 5,00,000 Major 3rd Spell + Rs.29,584/- SFMS 2018-19] including present sanction to Smt. Katta Aruna Kumari W/o Late (Sri) L. Subrahmanyam, Ex-EE/Civil/VS/VJA. The Pay Officer/VS/VJA is requested to arrange to enter the same in pensioner records of the above individual and report compliance.

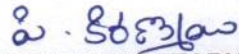
