ORDER:

Aggrieved by an Orders dt.19.10.2023 passed by the Hon'ble High Court of Telangana in WP.No.37555/2022 & WP.No.37599/2022 filed by TSSPDCL & 2 others, the APGENCO has filed SLP(C) No.26879-26880/2023 before the Hon'ble Supreme Court of India against the TSSPDCL & TSNPDCL and TS Power Co-ordination Committee for payment of Rs.6756.92Crores out of which Rs.3441.78 Crores is towards the Principal and Rs.3315.14 Crores (up to 31.07.2022) towards late payment surcharge.
