ORDER :

Under Regulation 14 (a) (1) of A.P.S.E.B. SRs Part -II, as adopted, Sri D.Gangadhara Rao, Emp ID:1026616, Accounts Officer/Dr.NTTPS is hereby promoted temporarily to act as Senior Accounts Officer with effect from the date of assumption of charge:

2. The promotion ordered in para -1 above is purely temporary and liable to be terminated at any time without notice and without assigning any reasons thereto.
3. The promotion ordered in para -1 above is subject to the result of S.L.P.Nos.2360 -91/83 filed by the Retired Officers of the erstwhile APSE Board pending in the Honourable Supreme Court of India and W.P. No.1173/91 pending in the Honourable High Court of Andhra Pradesh and also subject to the outcome of W.P.No.39011/2017 and W.A.No.657/2024 pending in Hon'ble High Court of A.P.
4. This promotion was issued subject to the outcome of the six members committee constituted vide TOO(Addl Sec-Per)/MS No.4321, Dt. 20.07.2026, to examine the implications of implementation of GOMS No.45 Fin(HR.4-FR&LR) Dept, dt.02.07.2026 relating to enhancement of the age of superannuation from 60 to 62 years in respect of employees of AP Power utilities.
5. The Accounts Officer, on temporary promotion as Senior Accounts Officer and 01 No. SAO transferred and posted to the places noted against their names in the Annexure Appended to this order. The promotee/transferee are directed to assume charge at the place of posting ordered.
6. The concerned controlling officers are requested to relieve the promotee and transferee by making local arrangements so as to enable them to assume charge at the place of posting ordered. The alternate arrangements issued if any stands cancelled on assumption of charge by the concerned promotee/transferee.
