The promotion ordered in para -1 above is subject to the result of S.L.P.Nos.2360 -91/83 filed by the Retired Officers of the erstwhile APSE Board pending in the Honourable Supreme Court of India and W.P. No.1173/91 pending in the Honourable High Court of Andhra Pradesh and also subject to the outcome of W.P.No.39011/2017 and W.A.No.657/2024 pending in Hon'ble High Court of A.P.
4. These promotions are issued subject to the outcome of the six members committee constituted vide TOO(Addl Sec-Per)/MS No.4321, Dt. 20.07.2026, to examine the implications of implementation of GOMS No.45 Fin(HR.4-FR&LR) Dept, dt.02.07.2026 relating to enhancement of the age of superannuation from 60 to 62 years in respect of employees of AP Power utilities.

Necessary departmental disciplinary action as deemed fit shall also be initiated against them for non-compliance of the orders issued above. No request for change of posting or sanction of leave will be entertained.
