No.1173/91 pending in the Honourable High Court of Andhra Pradesh and also subject to the outcome of W.P.No.39011/2017 and W.A.No.657/2024 pending in Hon'ble High Court of A.P.

These promotions are issued subject to the outcome of the six members committee constituted vide TOO(Addl Sec-Per)/MS No.4321, Dt. 20.07.2026, to examine the implications of implementation of GOMS No.45 Fin(HR.4-FR&LR) Dept, dt.02.07.2026 relating to enhancement of the age of superannuation from 60 to 62 years in respect of employees of AP Power utilities.
5. The above 2 Nos. Assistant Accounts Officers on temporary promotion as Accounts Officers and 02 Nos. Accounts Officers are transferred and posted to the places noted against their names in the Annexure Appended to this order. The Promotees/transferees are requested to assume charge as Accounts Officer at the place of posting ordered. 1 No. Accounts Officer post diverted from Vidyut Soudha to Machkund vide reference 3rd cited.

If he/she fails to join or evade joining within 15 days or proceeded on leave, their promotion right shall be forfeited for the current panel year and the name of such candidate shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancies, in terms of orders issued in the reference 1st cited. Necessary departmental disciplinary action as deemed fit shall also be initiated against him for non-compliance of the orders issued above. No request for change of posting or sanction of leave will be entertained.
