2) In ref. 3rd cited, Sri G.N.V.K.Chaitanya, AEE/Dr.NTTPS has submitted actual medical bills for the treatment taken for an amount of Rs.7,13,644/- and remaining unutilized amount of Rs.2,93,356/- was remitted to Pay Officer APGENCO, current account (IFSC SBIN0016576) vide UTR No.TXN ID.239305022 dtd.14.11.2022.

3) After careful consideration, sanction is hereby accorded for an amount of Rs.7,13,644/-(Rupees Seven lakhs thirteen thousand six hundred and forty four only) towards actual expenses incurred for kidney transplantation to Sri G.N.V.K.Chaitanya,AEE/Dr.NTTPS against advance amount sanctioned for Rs.10,07,000/-and the un-spent amount of Rs.2,93,356/- remitted to APGENCO current account. The said amount is accountable under Major 1st & 2nd Spell ceiling limits.

4) The Original medical bills of Sri G.N.V.K.Chaitanya,AEE/Dr.NTTPS for the treatment of Kidney transplantation surgery at M/s Asian Institute of Nephrology and Urology Hospital, Visakhapatnam for an amount of Rs.7,13,644/- is submitting to the Accounts Officer (CPR)/APGENCO.

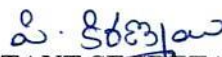
