ORDER:

Sri V. Venkata Siva Narayana, MCP Driver/Dr.MVR RTPP has represented vide ref 4th cited, that his wife Smt V.Lakshmi Devi, has undergone surgery for Decreased Donor renal Transplantation at M/s Yashodha Hospital, Hyderabad on 28.02.2023 and she has undergone treatment as inpatient during the period 27.02.2023 to 06.03.2023 and incurred an amount of Rs.12,39,359/- for the treatment. Whereas, sanction accorded for an amount of Rs.95,795/- for the said treatment under the medical policy of APGENCO vide memo 3rd cited. He has requested to sanction the balance amount of Rs.11,43,564/- on humanitarian grounds.

2) The APGENCO Board in its 200th meeting held on 15.05.2024 has accorded approval for sanction of balance amount of Rs.11,43,564/- (Rupees Eleven lakhs Forty three thousand Five hundred and Fifty four only) towards the medical expenses incurred by Sri V.Venakta Siva Narayana, MCP Driver/Dr.MVR RTPP for life saving surgery Decreased Donor Renal Transplantation of his wife Smt.V.Lakshmi Devi in relaxation of the existing medical policy of APGENCO vide G.O.O. 1st cited, as a special case on humanitarian grounds.

3) After careful consideration, sanction is hereby accorded for payment of Rs.11,43,564/- (Rupees Eleven lakhs Forty three thousand Five hundred and Fifty four only) to Sri. V. Venakta Siva Narayana, MCP Driver/Dr.MVR RTPP towards reimbursement of medical expenses incurred for the lifesaving surgery "Decreased Donor renal Transplantation" to his dependant wife Smt V. Lakshmi Devi in relaxation of G.O.O. 1st cited as a special case.
