2. The Dearness Allowance shall be paid on basic pay only (excluding personal pay) as per the increased rates as mentioned above.

3. The Dearness Allowance/Dearness Relief to the Employees and Pensioners/Family Pensioners respectively sanctioned as per increased rates shall be paid in cash along with Salary/Pension for the month of September 2026 payable in the month of October 2026. The arrears on account of payment of Dearness Allowance/Dearness Relief shall be paid in 12 equal installments with effect from the salary/pension/family pension for the month of September 2026 payable in October 2026.

4. The Dearness Allowance so calculated shall be rounded off to the nearest rupee and Dearness Relief so calculated shall be rounded off to the next rupee.
