02). The CE/O&M/Dr.NTTPS, CE/O&M/RTPP, CE/O&M/LSHES/ Mothugudem & CE/O&M/SRBHES have informed that no candidate is eligible as none have fulfilled the instructions mentioned in the Memo 5th cited.

Therefore, I am to inform that as per the minutes communicated vide letters 1st to 4th cited, the request was examined in detail as stated above and it is found that none of the employees could produce the documentary evidences as required for in the memo 5th cited.
