In modification to the orders issued vide references 15th and 16th cited, the APGENCO hereby issues orders as follows:

- i) The Employees who have retired on attaining the age of 58 years and not completed 60 years of age as on the date of issue of these orders and not re-inducted into service as per the orders issued vide references 15th and 16th cited, they are permitted to re-induct into service without any remittance of Retirement/Pensionary benefits already paid to them (including Retirement Gratuity).
- ii) The terminal benefits shall be reworked at the time of retirement on attaining the age of 60 years and the terminal benefits already paid to those employees shall be adjusted against from the amount of reworked terminal benefits.

2) The other terms and conditions mentioned in the references 15th and 16th cited remain unaltered.
