In the reference 1st cited Notification has been issued for filling up of the post of Assistant Engineer by Direct Recruitment. As per rules/procedure in vogue, whenever Direct Recruitment of Assistant Engineer taken place, Sub-Engineers having Degree qualification & Diploma qualification are being considered for the post of AE/AAE by way of appointment by transfer method of recruitment as detailed below:

- (i) 10% against Direct Recruitment notified vacancies are being considered to be filled up with Sub-Engineers possessing B.Tech. qualification having 4 years experience and
- (ii) Sub-Engineers possessing Diploma Qualification and having 8 years of service (now 5 years) are being considered for appointment by transfer as AAEs in the ratio of 3:2 against notified vacancies of Direct Recruitment.
- 2. Accordingly, in the references 2nd & 3rd cited, 8 Nos. Graduate Sub-Engineers and 50 Nos. They are posted as Additional Assistant Engineers (Elecl, Mechl & Electronics) to the places noted against their names in the Annexure appended to this memo.
- 4. Their appointments ordered above shall be subject to the following conditions;
 - They are purely temporary and do not confer any right to regular appointment as Additional Assistant Engineers (Elecl., Mechl., & Electronics).
 - ii) They are liable for termination at any time without notice and without assigning any reasons thereto.
 - They are subject to production of physical fitness certificate issued by a Medical Officer of a rank not less than that of Civil Surgeon at the time of joining as Additional Assistant Engineer (Elecl., Mechl., & Electronics).
 - iv) The candidates should produce original certificates of Diploma,PH and Age, i.e.Date of birth Certificate for verification by the concerned controlling officer at the time of joining as Additional Assistant Engineer (Elecl., Mechl.,& Electronics).
 - v) The candidates shall have to pass the prescribed tests as per APSEB Service Regulations as adopted.
 - vi) The candidates shall join duty within 15 days from the date of their relief.

- vii) The candidates are informed that if they do not report as Additional Assistant Engineer within 15 days duly obtaining proper relief, the orders of their appointment by transfer as Additional Assistant Engineer shall be cancelled without further notice.
