**ORDER:**

The Unions/Associations representing the employees of Andhra Pradesh Power Utilities have requested the Management to deduct One (1) Day Basic Pay from all the employees of AP Power Utilities (APTransco, APGenco, APSPDCL & APEPDCL) and transfer the same to the Kerala Chief Minister Relief Fund, so as to extend their contribution to the flood victims of the Kerala State.

2. APTransco, after careful consideration and with the consent of the Managing Director /APGenco and Chairman and Managing Directors of APEPDCL and APSPDCL hereby directs to deduct One (1) Day Basic pay as on 01.08.2018 towards contribution to the Kerala Chief Minister Relief Fund for the victims of Kerala floods.
3. The following working instructions are issued:
  - a) The deduction towards One (1) Day Basic Pay is applicable to all the employees working in A.P Transco, APGenco, APEPDCL and APSPDCL
  - b) The amount of deduction shall be rounded off to the nearest rupee
  - c) The deduction of One (1) Day Basic Pay as on 01.08.2018 shall be recovered from the pay bills of September 2018 payable in October 2018.
  - d) The total amount thus recovered from each of the employee shall be credited to a separate General Ledger Account.
  - e) The amount so credited is to be shown distinctly in the trial balance without clubbing with other remittances. The employee wise details of recovery schedule duly tallying with the amount shown in trial balance is to be furnished along with the Trial Balance.
  - f) The recovery particulars indicating the name of employee, Designation and amount particulars may be furnished to Pay Officer, O/o.FA&CCA (Accounts)/ APTransco.
4. The Pay Officer, APTransco is directed to pay the total amount of One (1) Day Basic Pay as on 01.08.2018 of the employees of APTransco, APGenco and AP Discoms immediately in the form of Cheque to the Kerala Chief Minister Relief Fund on behalf of all the Andhra Pradesh Power Utilities and the share of each Power Utility shall be get reimbursed from the A.P. Discoms/ APGenco subsequently.
